1.1 Analysis of the needs and priorities in Serbian society and local economy

Activities WP1 should include:

- Defining a set of indicators for monitoring conditions in institutions of higher education. The set of indicators will be created on the basis of priorities and objectives of the national strategy, policies and existing documents and the actual situation and the economy, and at universities in Serbia. (For example, a set of indicators should include the unemployed highly educated staff to determine the causes and character, etc)
- The application of standards for accreditation (assessment of current standards for accreditation against the priorities and targets in the preceding paragraph).
- Development of a conceptual model of implementation of indicators through information system (development and setting of an integrated information system in order to monitor performance and progress in the implementation of standards and on-line information available in real time.
